

# MEMORANDUM OF UNDERSTANDING FOR ACADEMIC COOPERATION

**Terms-** This Agreement will become effective upon the date of signature by both parties. It shall remain valid for a period of two (2) years from the date of the last signature, with the understanding that it may be modified by written mutual consent of both parties. This Agreement may be terminated by either Party with advance written notice of at least thirty (30) days.

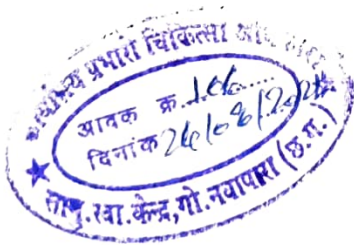



2. Termination: This MoU is signed for the period of five years. Further renovation will be made by mutual understanding between two parties.


#### VI. FUNDING
